They are welcome to limit the guarantee for 20-business days post auction, but the **LETTER MUST CONTAIN LANGUAGE STATING THEY WILL "GUARANTEE AND HONOR PAYMENT"**.*

Unfortunately, a letter stating that you are a valued customer, a letter of credit or a bank statement is NOT an acceptable form of guaranteed payment.
